The Portsmouth Athenaeum is a private, nonprofit membership library, which makes available images and reproductions from our collections for personal, educational, and commercial use. In consideration for this usage, reproduction and use fees will be assessed to offset the costs of acquiring, cataloging, and preserving these materials.

- ❑ Any usage requests from nonprofit organizations must be signed by the executive director or similar role.
- ❑ Requests for images should be as specific as possible. Search the Athenaeum's online catalog, athenaeum.pastperfectonline.com/search, and include the object identification number provided.
- ❑ Images may not be altered or manipulated beyond the requirements of normal enhancement or cropping.
- ❑ The Athenaeum requests that it receive at least one copy of any publication containing reproductions of its materials.
- ❑ The Portsmouth Athenaeum reserves the right to modify or deny requests for images and reproductions.

Using or distributing reproductions and images of materials from the Portsmouth Athenaeum's collections without written permission is illegal except in circumstances allowed by fair use per United States copyright laws.

Credit:

Reproduction Charges:

B&W photocopies (Proprietors, Subscribers, Friends):	\$0.10/page
B&W photocopies:	\$0.25/page
Color photocopies:	\$1.00/page
PDF scans of documents:	\$0.50/page

Use Fees:

Fees charged for one time, nonexclusive use of Portsmouth Athenaeum high-resolution images. Any subsequent use or reuse must be applied for in writing.

Note that Use Fees are in addition to Reproduction Charges. Terms are subject to change.
